NZTA to present updated conditions and any associated expert evidence.

DOC, Ngāti Tama, and any other submitter who files evidence in response to the updated NZTA conditions to present their evidence.

NPDC and TRC staff to present their updated reports and any final recommendations.

Initial right of reply by NZTA.

Wednesday 10 October

Backup hearing day if required.

Wednesday 17 October

Written closing to be filed by NZTA.
