Prior to the Commissioner adjourning the hearing on Friday 26 July, the Commissioner requested the applicant's counsel provide a memorandum, outlining the suggested further process as the applicant sees it. This was provided on 31 July 2019. This was forwarded to the commissioner the same day.

My understanding was that all parties received a copy of that memorandum as per the commissioners request. It has been clarified that that did not occur — it was instead sent only to the legal counsel representing some submitters. The legal counsel for those submitters then chose to respond with a memorandum. The applicant's legal counsel then forwarded a subsequent memorandum. All three memoranda are now available on the Council's website.

As per the direction given at the hearing, the Commissioner and the

Commissioner's assistant are now considering the memoranda forwarded before issuing a direction on the forward process.
