Disconnection (charge per visit, with no charge for initial visit)	\$121.50
<p>Note: Permanent disconnection: you do not need the water service in your property. You need to submit an application for disconnection. No fee is required. The dwelling must be vacated before the nominated date for disconnection. If the dwelling is not vacated on the nominated disconnection date, further visits will be required, each subsequent visit will be charged as a secondary inspection.</p> <p>Temporary disconnection: you will need the water service in the property after the removal or demolition work. You do not need to apply for a temporary water disconnection. You will need to call a plumber to disconnect the water on your side of the toby. This must be done before the building work starts in order to prevent clogging or damage to pipes.</p>
